In Choosing the Driver Improvement Course, the following apply:

1. Driver Improvement Course must be completed within 60 calendar days from your payment date.
2. Pay School Fine amount (**See Fine Chart**) (**OPTION #2**) within 30 calendar days to:
Charlotte County Court, Traffic, 350 East Marion Ave., Punta Gorda, Florida 33950, or
P.O. Box 512408, Punta Gorda, Florida 33951-2408. (**Do not send cash**). (**Disregard amount indicated on the back of your citation.**)
3. **You must provide proof** of completion of a Certificate number or a School Completion to the Clerk's Office within **60 calendar days** from your payment date.
4. **You may pay online @ www.myfloridacounty.com within (30) calendar days from ticket date.**

Penalties for Failure to Complete Driver Improvement Course:

1. Your Driver's License will be suspended, and points will be assessed pursuant to Florida law. Before your license can be reinstated, you must:
 - A. Pay a **\$18.00** processing fee.
 - B. Pay an **\$23.00** late fee.
 - C. Pay a **\$60** reinstatement fee to either the Clerk of Court, or to the Department of Highway Safety Motor Vehicle Office (if applicable).
