PLEASE CONTACT THE COURT **BEFORE** SENDING IN THE REQUEST FOR DRIVERS SAFETY COURSE TO DETERMINE IF YOU ARE ELIGIBLE. IF YOU HOLD A CDL LICENSE OR ARE CHARGED WITH SPEEDING 25 MPH OR MORE OVER THE POSTED SPEED LIMIT YOU WILL **NOT** BE ELIGIBLE FOR THE DRIVERS SAFETY COURSE.

THE ITEMS LISTED BELOW ARE **REQUIRED** AND **MUST** BE RECEIVED BY THE COURT ON OR BEFORE YOUR LISTED APPEARANCE DATE:

1. Request for Driver Safety Course.
2. Payment of fee in the amount of \$107.00.
3. Copies of valid Texas Drivers License and Auto Insurance.

You will have 90 days to complete your course and an additional 30 days to return the completion certificate to the court. A copy of your driving record will also be required and the court will provide you with the request form.

I UNDERSTAND THAT IF I DO NOT FULFILL ALL THE REQUIREMENTS, MY CASE WILL NOT BE DISMISSED AND THE REMAINING BALANCE ON MY CITATION WILL BE DUE. IF NOT PAID A WARRANT WILL BE ISSUED FOR MY ARREST AND I WILL ALSO BE RESPONSIBLE FOR PAYING A WARRANT FEE.
