I HEREBY ACKNOWLEDGE THAT IN ORDER TO TAKE AN APPROVED DRIVING SAFETY COURSE IN LIEU OF A CONVICTION BEING ENTERED ON MY DRIVING RECORD, THAT:

- 1. I hold a valid Texas Driver's License. (Copy must be furnished with this request).
- 2. I have valid, current liability insurance that meets Texas minimal requirements. (Copy must be furnished with this request).
- 3. I have not taken a Driving Safety Course during the preceding 12 months.
- 4. I am not currently signed up to take a Driving Safety Course for any other traffic violation.
- 5. I understand that I have 90 calendar days from today's date to complete an approved 6-Hour Driving Safety Course.
- 6. I am responsible for returning to this Court written proof showing that I have completed the Driving Safety Course within 90 days from today's date.
- 7. I am responsible for returning to this Court a copy of my driving record obtained from the Texas Department of Public Safety along with the Court copy of my Driving Safety Course.
- 8. I understand that non-compliance with any portion of part 1, 2, 3, 4, 5, 6, or 7 listed above will result in the Court issuing a Warrant for my arrest.
- 9. I understand that when I have completed the Driving Safety Course and have returned proof thereof, the Court will dismiss my traffic citation and that the violation will not appear on my driving record.
- 10. I understand that the school offering the Driving Safety Course class will charge a fee for the course.
- 11. I understand that I must pay all mandatory Court costs plus administrative fee totaling \$102, (\$117 for offenses occurring in a school zone) and that these costs/fees are non-refundable whether or not I successfully complete the Driving Safety Course.
- 12. I hereby waive my right to trial and I enter my Plea of Guilty Nolo Contendere. If I decide not to take the course within 90 days the balance of the fine will be due & a conviction will be entered into my driving record.
